USE OF PENSION INCOME IN CALCULATION OF UI BENEFITS

Mr. Nelson A. Riis (Kamloops—Shuswap): Mr. Speaker, it is my pleasure to once again present a petition on behalf of a number of residents of Kamloops, British Columbia, who are still concerned about the announcement by the Minister of Employment and Immigration (Miss MacDonald) that laid off workers, after January 1, 1986, will have their pension benefits deducted from their unemployment insurance benefits. They call upon the Government to ensure that all retired employees keep their pension benefits and receive their unemployment insurance benefits without deduction of pension income.

RIDEAU HALL—PUBLIC'S ACCESS TO GROUNDS

Mr. Jean-Robert Gauthier (Ottawa—Vanier): Mr. Speaker, I have several petitions from residents of Canada concerned about the closure of the grounds of the Governor General's residence. The petitioners call upon Parliament to open up that decision in consultation with a group of residents who are representative of the large and growing opposition to the closure of those grounds in order that a modus vivendi be created that will satisfy both the Government and the public. The petitions are signed by several hundred petitioners.

USE OF PENSION INCOME IN CALCULATION OF UI BENEFITS

Mr. John R. Rodriguez (Nickel Belt): Mr. Speaker, I have the responsibility and duty to present a petition signed by many residents of Kamloops, British Columbia. They protest changes to the Unemployment Insurance Act which see pension income treated as earned income for unemployment insurance purposes. They call upon Parliament to withdraw this iniquitous provision.

PRICE OF GASOLINE—REQUEST FOR WITHDRAWAL OF FEDERAL SALES TAX

Hon. Lloyd Axworthy (Winnipeg—Fort Garry): Mr. Speaker, I have the honour to present close to 10,000 names on a petition from the Province of Manitoba. The petitioners request that the major sales tax applied to gasoline at the federal level be withdrawn and that a federal-provincial conference be called at the earliest possible moment to discuss how a major reduction in the price of gasoline can be effected at both the federal and provincial level. There are 10,000 names which represents close to 5 per cent of all the drivers in Manitoba.
