## RIGHTS OF THE UNBORN

**Mr. Ross Belsher (Fraser Valley East):** Mr. Speaker, it is my duty and privilege to present, on behalf of constituents of Fraser Valley East, a petition to the House asking that the government and Parliament enact legislation which will effectively protect the life of the pre-born child without distinction as to the stage of development.

## HOUSING

**Mr. David Bjornson (Selkirk):** Mr. Speaker, I have the honour to present a petition on behalf of the minister from Don Valley East signed by petitioners from across Canada who call upon Parliament to live up its 1986 commitment to sponsor 5,000 new co-operative housing units a year under the federal ILM program.

They also call upon Parliament to use its influence with provincial ministers of housing to ensure that 50 per cent of the co-op housing units developed since 1986 be made available to low income earners through provisions of rent supplements.
