Next month the Prime Minister and the premiers of the provinces, with the ministers of finance, will have a meeting on all these matters. I am devoting all my time to that. However, I am not neglecting the other problems in Quebec. I believe I have to remain in Canada and fight for it. I will not make any cosy deal with Lévesque.

REQUEST FOR REASSESSMENT OF GOVERNMENT'S EMPLOYMENT PROGRAMS

Mr. James A. McGrath (St. John's East): Mr. Speaker, my supplementary question is to the Minister of Employment and Immigration. Following the release by Statistics Canada earlier this month of the unemployment figure, showing 8.5 per cent—an all-time high rate of unemployment for the country—the minister is reported as having said, and I quote, "the system is probably working as well as it can, given the plight of the western world economy". While he was saying that, the OECD were issuing a report saying that Canada had the worst record of unemployment of any industrialized country in the western world.

I ask the minister, who I suspect is a little shaken up, having to bear this terrible burden of unemployment under this government, on behalf of the one million unemployed Canadians in this country, many of whom are facing hardship, whether he is prepared to reassess the government's employment programs in light of the failure of these programs to have any significant impact upon the terrible unemployment situation in the country.

Hon. Bud Cullen (Minister of Employment and Immigration): Mr. Speaker, I will try to be precise. I suggest to the hon. member that he read more carefully the OECD report, which indicated that Canada ranked number three among the countries that faced better prospects for recovery. We were after Japan and the United States as the third country that would, in fact, recover. I have indicated to ministers at provincial conferences that I am quite prepared to look at the Canada Works program to see if we can build in the economic growth component and work toward a more permanent type of job creation. We have had a twelvefold expansion in our job experience training program. That has been successful. The work sharing program now comprises some 12 different projects, where people are working who would not be working if we had listened to the opposition parties and had taken it out of the recent legislation. Therefore, we are doing our bit.

REQUEST FOR FEDERAL-PROVINCIAL DISCUSSIONS ON INCREASED COST OF WELFARE BENEFITS
