At the risk of being accused of beating a dead horse or having to have the last word the Excalibur staff wishes to respond to the half-page ad which YUSA placed in last week's issue.

We do so partly because what is at issue, the ability to efficiently cover the news, is of importance, but also because YUSA's complaints and their rebuttal deal primarily with bad reportage—somthing of which their response to our editorial is guilty.

Ms. Harrell points out in her reply that the first Excalibur reporter she spoke with was both in experienced and lacking background knowledge concerning YUSA. Ms. Harrell could have taken the time to explain what YUSA is and how its negotiations were being conducted. That is why the reporter is there—to get information. Reporters are not

Ms. Harrell and Ms. Schmid want fair coverage—and so do we. Too bad for Ms. Harrell and Ms. Schmid that our idea of fair does not include myopia, casting aspertions or misrepresenting facts.
