

A.325 Someone tried to plant it on me, I wouldn't sign my name "Tommy" that isn't my handwriting.

Q.326 Ever have that book?

A.326 No, sir, not a Baptist book.

Q.327 You have got a minister, in your own words, in Newcastle, stationed in Newcastle, his name is Colwell?

A.327 Yes, sir.

Q.328 Write your own name, that is your regular signature. Also write "Thomas White, D.C. Schriver, William McDowell, John Adams, David Schriver, W.T. Furze, R. Reid," write your own name, "David Schriver, Joseph Anderson, William McDowell, Newcastle, D.C. Schriver, W.T. Furze, John Adams, Joseph Anderson, Newcastle." (witness writes as indicated).

(AT THE DIRECTION OF THE PROSECUTOR THE ACCUSED WROTE NAMES WHICH APPEAR IN EXHIBITS "N-1" and "N-2.")

Q.329 Is that your regular signature?

A.329 Yes, sir, Thomas White.

Q.330 How do you account for "T.J. White"?

A.330 Just in the Army, I sign like that.

Q.331 Write your regular signature then. (witness writes as indicated).

Q.332 In exhibits N-1 and N-2, "T.J. White" is your regular Army signature?

A.332 Yes, sir.

Q.333 That is your regular signature on form 513. You are batman to Major Reid?

A.333 Yes, sir, I was, but not now.

Q.334 You spent quite a bit of time in his room?

A.334 Yes, sir. In the morning, wake him up, shine his buttons.

Q.335 He allowed you to write letters there?

A.335 I think he was mistaken there because his room was just big enough to turn around in, I had no writing pad there.

Q.336 He said you did.

A.336 I say I didn't.

Q.337 He is lying then?

A.337 He is lying, I did not have any writing pad there in the room.

Q.338 Did you ever write any letters in his room?

A.338 Yes, sir, one or two, he was there at the time.

Q.339 You had no writing pad or paper there?

A.339 No, sir.

Q.340 Then, Major Reid is lying?

A.340 As far as the pad is concerned.

Q.341 Have you ever seen that before? (Exhibit "E").

A.341 At the Summary of Evidence.

Q.342 Not before that?

A.342 I claim no knowledge of it.

Q.343 I am going to put it to you that you disguised your writing?

A.343 No, sir.

Q.344 Then how do you account for "T.J. White" and this is your regular signature?
