*Ordered*, That the Petition of *J. D. Armour*, of the Town of *Cobourg*, County of *Northumberland*, presented this day, be now received and read.

And the said Petition was received and read; praying that the Bill to amend and extend the provisions of the Act incorporating the *Port Hope, Lindsay and Beaverton Railway Company*, and the Acts amending the same, may not become law.

*Ordered*, That the Petition of *Samuel S. Macdonell* and others, presented this day, be now received and read.

And the said Petition was received and read; praying for an Act of Incorporation under the name of "*The Windsor Ferry Company*."

Pursuant to the Order of the Day, the following Petitions were read:—

Of *William Notman*, of the City of *Montreal*; praying that the House will subscribe for a certain number of copies of a work intituled, "*Portraits of British Americans*."

Of the *Toronto Street Railway Company*; praying for the passing of an Act to enable them to dispose of the said Street Railway.

Of *John R. Dickson*, of the City of *Kingston*; praying for the passing of an Act to incorporate the "*Queen's College of Physicians and Surgeons, Kingston*."

Of *Joseph Robinson Bawden*, of the City of *Kingston*; praying for the passing of an Act to enable the Law Society of *Upper Canada* to admit him as an Attorney and Solicitor.

Of the Municipal Council of the County of *Perth*; praying for the passing of an Act to consolidate and extend the time of the payment of the Municipal Loan Fund Debt of the said County.

Of the Municipal Council of the County of *Perth*; praying for an investigation into the affairs of the *Canada Company*.

Of *E. O. Cuthbert* and others, of the Parish of *Berthier*, County of *Berthier*; praying that in the event of any Act being passed to regulate the Commons in *Lower Canada*, their interests may be protected.

Of the Rector, Churchwardens, and Vestry of *St. Paul's Church, Woodstock*; praying that the Bill to provide for the sale of the Rectoral lands in the Province, may not become law.

Of the Incumbent and Chapelwardens of *St. Michael's Chapel, Quebec*; praying for the passing of an Act to remove all doubts as to the legality of a certain Canon or By-law adopted at the Synod of the Diocese of *Quebec*, establishing certain Chapelries within the Parish of *Quebec*.

Of *P. R. Chevalier* and *C. L. Armstrong*, of the Town of *Sorel*; praying for amendments to the Bill to make more ample provision to the incorporation of the Town of *Sorel*.

Of Messrs. *Goldie McCulloch and Company*, and others, of *Galt*; praying that no change may be made in the Tariff in respect of machinery.

Of *D. McGregor* and others, of the Township of *Stanley*, County of *Huron*; praying that the amendments to the School Law of *Upper Canada*, proposed by the Superintendent of Education for *Upper Canada*, may not become law.

Of the Town Council of the Town of *Guelph*; praying for amendments to the Bill to consolidate and amend the Assessment Law of *Upper Canada*.

Of *Joseph Walker* and others, of the Township of *Niagara*; praying that duties be imposed upon Fruits, Vegetables, Plants and Trees imported from the *United States*.

Of *E. Burnham* and others, members of the Town Council of the Town of *Peterborough*; praying that the Bill to revive and extend the Act incorporating the *Peterborough and Chemong Lake Railway Company*, may become law.

Of the Town Council of the Town of *Peterborough*; praying that no Act may be passed to legalize By-law 187, of the said Town of *Peterborough*.

Of the *Kingston Sabbath Reformation Society*; praying for the closing of the Provincial Canals on the Lord's Day.

Of the Municipality of the Township of *Compton*; praying for the passing of an Act for the immediate settlement of the claims of the Townships of *Lower Canada*, in respect of the Seigniorial Amendment Act of 1859.
