## JAIL WATCHMAN SUSPENDED BY SHERIFF'S ORDER

Formality Necessary Until Investigation Is Made By Inspector Bruce-Smith.

MR. GRAHAM AFFECTED BY CHARGES MADE

Sheriff Believes Time-Clock in All Corridors To Be An Absolute Necessity.

Cameron has suspended Night Watchman Archie Graham, pending an investigation that will be conducted by the inspector of prisons, Dr. Bruce Smith, to whom all circumstances of the death of Alexander Hammer were forwarded. The verdict returned by the jury exonerated all the jail officials from negligence but the sheriff is compeled by his instrutions to forward the irumstanes of all suh ases to th edepartment at To-

The officials at the jail are incensed over the statement made to The Advertiser by Mr. August Hammer on Wednesday, in which he stated that the night watchman was asleep, and if he had been attending to his duties, his brother would not have been able to commit suicide.
