

REPORT TO THE HOUSE**Thursday, December 12, 1985**

The Legislative Committee on Bill C-65, An Act to amend the Royal Canadian Mounted Police Act and other Acts in consequence thereof, has the honour to report the Bill to the House.

In accordance with its Order of Reference of Thursday, September 12, 1985, your Committee has considered Bill C-65 and has agreed to report it with the following amendments:

Clause 1

In the English version only, strike out line 30, on page 2, and substitute the following therefor:

“erking the Commissioner to make rules shall be known as”

Clause 2

Delete line 38, on page 2.

Clause 3

In the English version only, strike out line 42, on page 2, and substitute the following therefor:

“to any member any of the Commissioner’s powers, duties or”

Clause 5

In the English version only, strike out line 28, on page 3, and substitute the following therefor:

“(c) where the Commissioner is requested by any”

In the English version only, strike out line 33, on page 4, and substitute the following therefor:

“cer has by law until the officer or person is dismissed or”

In the English version only, strike out lines 36 and 37, on page 4, and substitute the following therefor:

“sioner’s standing orders or until the appointment of the officer or person expires or is revoked.”

In the English version only, strike out lines 40 to 42 inclusively, on page 4, and substitute the following therefor:

“unless that person is a Canadian citizen, is of good character and has the necessary physical qualities and, in the case of a member other than an officer, that person”

In the English version only, strike out line 9, on page 5, and substitute the following therefor:

“able to that person may be appointed to be a”

Clause 9

In the English version only, strike out line 34, on page 5, and substitute the following therefor:

“entering upon the duties of the member’s office, take”

Clause 12

In the French version only, strike out line 16, on page 6, and substitute the following therefor:

“Commissaire peut prendre des règles.”
