Budget, 1614. Survey of events which have indirectly influenced the balance sheet; substantial development throughout Canada; railways not called upon to move harvesters to prairies for last season's harvest; grain-producing and marketing; Canada ranks seventh in world manufacture; industrial efficiency of Canada; increase in per capita production, 1614; stock market speculation; delayed marketing of grain crops; record of Hon. Mr. Robb as finance minister; annual decrease in the public debt; survey by Board of Audit of operations of Soldier Settlement Board; final accounting for the fiscal year not completed; abolition of "nuisance" taxes in 1929 and reduction of the sales tax account for reduction in revenue; increase in revenue from the income tax, post office and excise; comparison of estimated revenue, 1929-30, with actual revenue for 1928-1930, 1615-16; expenditures on capital account carrying out capital expenditures without borrowing, 1616; deficits of Canadian National Railways; loans to Canadian Government Merchant Marine, Canadian National Steamships and Quebec harbour commission; detailed comparison of estimated expenditures, 1929-30, and actual expenditures for fiscal year 1928-1929, 1917; expenditures attributable to war; estimated revenue for 1929-1930 by services with percentage of total revenues, 1618; estimated surplus over all expenditures of \$44,507,000; retiring of maturing loans out of surplus revenues, 1619; decrease in annual interest charges; debt-financing problem; re-financing the 1933 and 1934 loans; statement showing debt retirements each year out of surplus revenues, 1620; statement showing unmatured public debt held by the public; financing of subsidiary enter-
