YUKON-STORAGE DAM SITES

Question No. 805-Mr. Nielsen:

1. What storage dam sites in the Yukon, if any, have been examined during each of the years 1960 to 1967 inclusive?

2. In each case, has a report on such site been submitted to the government and, if so, what is the nature of the contents and recommendations, if any, of each such report?

Hon. Judy V. LaMarsh (Secretary of State): In so far as the Department of Energy, Mines and Resources is concerned: 1. Upper and Lower Porcupine Canyon on Porcupine river, 1962 and 1964; Bell Site on Porcupine river, 1963 and 1964; Summit Lake on Porcupine and Rat rivers, 1962 and 1963; Selwyn on Yukon river, 1960; Fort Selkirk Draw on Yukon river, 1960; Upper Ogilvie on Yukon river, 1961; Lower Ogilvie on Yukon river, 1961; Gerc on Pelly river, 1961; Hoole on Pelly river, 1965; Detour on Pelly river, 1966; Granite Canyon on Pelly river, 1966; Aberdeen Falls on Peel river, 1962 and 1964; Wind River on Peel river, 1962 and 1964; Bonnet Flume on Peel river, 1962 and 1964; False Canyon on Frances river, 1961 and 1962; Lower Canyon on Frances river, 1962; Upper Canyon on Frances river, 1965; Upper and Lower Liard Canyon on Liard river, 1961 and 1962; Lower Canyon on White river, 1961; Kluane Canyon on Kluane river, 1962; Ross Canyon on Ross river, 1962; Prevost Canyon on Ross river, 1967; Fraser Falls on Stewart river, 1965; Five Mile Rapids on Stewart river, 1965; Kathleen Lake on Kathleen river, 1961; Otter Falls on Aishihik river, 1967.

In so far as the Department of Indian Affairs and Northern Development is concerned:
1. and 2. The only relevant information which is in the possession of the Department of Indian Affairs and Northern Development concerns the study of the Yukon's hydroelectric requirements on a long term basis as dictated by the area's existing and potential nonrenewable resources developments. This study is being carried out by the firm of T. Ingledow and Associates Limited and, although a preliminary copy of the Ingledow report has been received, the full report will not be available for some time.

HIGHWAY IN PRINCE EDWARD ISLAND NATIONAL PARK

- 1. When did construction commence on the gulf shore highway in the Prince Edward Island national park?

- 4. What was the total cost of the highway so far completed?
- 5. Is it intended to construct the portion of the highway across Rustico harbour?
- 6. Has the National Research Council completed its study of the feasibility of constructing this portion of the highway?
- 7. How long has the project been under study? 8. What government departments have been in-
- volved?

 9. What is the distance by existing highways between portions to gulf shore highway on either side of Rustico harbour?

Hon. Judy V. LaMarsh (Secretary of State): I am informed by the Departments of Indian Affairs and Northern Development and Defence Production as follows: 1. Work commenced on this highway on April 25, 1956.

- 2. Work ceased November 6, 1965.
- 3. The highway is 20.0 miles in length.
- 4. Construction costs were \$2,955,743.38. In addition, engineering fees of approximately 5 per cent were paid to the Department of Public Works.
- 5. Due to the high cost, it does not appear to be practical to construct the bridge at this time.
- 6. The division of mechanical engineering carried out engineering studies during 1962 and 1963 and submitted laboratory memoranda to the Department of Public Works containing tentative proposals of various schemes of constructing a highway across the entrance of Rustico Harbour.

- 8. The Department of Indian Affairs and Northern Development, the Department of Public Works and the National Research Council.
- 9. The distance from Brackley beach to Rollings Pond, around Rustico Harbour, is 12 miles.
