PROPOSED RECONSIDERATION OF ADMISSION FEE TO LOWER FORT GARRY—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, I rise to propose a motion under the provisions of Standing Order 43. I do so because in these days when Canadians are being urged to be interested in the heritage that is ours we in Manitoba find it difficult to understand the rather exorbitant fee that is to be levied, starting April 1, for admission to Lower Fort Garry on the Red River, in our province of Manitoba. I therefore move, seconded by the hon. member for Nanaimo-Cowichan-The Islands (Mr. Douglas):

That this House urges the Minister of Indian Affairs and Northern Development to cancel the proposal, which has been set to come into effect on April 1, to charge a fee of \$2 per person or \$5 per family for admission to Lower Fort Garry, a place which should be open to all Canadians who wish to visit it, Lower Fort Garry being part of our western heritage and truly a national historic site.

Question No. 813-Mr. Stevens:

- 1. As of March 31 in each year 1968, 1970, 1972 and 1974 (a) how many were employed by the Company of Young Canadians (b) what would have been their aggregate salaries if all were employed for a full year (c) how many had salary levels of (i) \$20,000 or more (ii) \$35,000 or more?
