PROPOSED DENIAL OF LANDING RIGHTS TO AIRCRAFT OF COUNTRIES HARBOURING AIRCRAFT HIJACKERS—MOTION UNDER S.O. 43

SUGGESTED MORATORIUM ON GARRISON DIVERSION PENDING REPORT OF INTERNATIONAL JOINT COMMISSION—MOTION UNDER S.O. 43

### AIR TRANSPORT

SUGGESTION MINISTER OF TRANSPORT DISAVOW AGREEMENT WITH AIR TRAFFIC CONTROLLERS AND MAKE PUBLIC APOLOGY—MOTION UNDER S.O. 43

**Mr. René Matte (Champlain):** Mr. Speaker, pursuant to the provisions of Standing Order 43, I request the unanimous consent of the House to move a motion on an important and urgent matter.

Given the situation resulting from the government's surrender to CALPA and CATCA regarding bilingual communications over the Quebec territory; considering that the decision of the Minister of Transport is at best an alarming commitment which contradicts the very principles of the bilingualism act, besides further breaking the ties between Quebec and the rest of Canada; and considering that this protocol insults all members of parliament and particularly upsets French-speaking representatives, I move, seconded by the hon. member for Shefford (Mr. Rondeau):
