Because of the inability of the Department of Supply and Services to honour a firm contract it made with the transportation contractors for the carriage of aid wheat from west coast Canadian ports to Bangladesh, all because of a bureaucratic entanglement involving the Department of Supply and Services, CIDA, the Canadian Wheat Board and the Department of Justice, I move, seconded by the hon. member for Winnipeg-Assiniboine (Mr. McKenzie):

That the Minister of Justice, the Secretary of State for External Affairs, the minister responsible for CIDA, the minister responsible for the Canadian Wheat Board, the Minister of Supply and Services and, if necessary, the President of the Treasury Board, call an emergency meeting with their officials and out of that meeting give an assurance to Maritime Agencies Ltd. that past due damages in excess of \$450,000, and a commitment to Maritime Agencies Ltd. on substantiated costs due to lack of grain being delivered to the port on present contracts, will be forthcoming immediately, in order to prevent an unnecessary bankruptcy with loss of jobs and subsequent action against the Crown by creditors.
