INQUIRY CONCERNING GOVERNMENT POLICY ON TRANSFER

At the recent federal-provincial conference held last week he mentioned that he was prepared to consider transferring to the provinces the various home insulation programs. Could the Prime Minister clearly state the policy of his government on this?

Right Hon. Joe Clark (Prime Minister): Mr. Speaker, the policy, as I asserted during the conference of first ministers, is that this is something we are prepared to consider as part of a general agreement with the provinces, aimed at making progress toward energy self-sufficiency.

Mr. Tousignant: Mr. Speaker, on a supplementary, can the Prime Minister tell us where the government will stand in case of conflict once Canada has turned all these jurisdictions over to the provinces, given the fact that powers do not fall from heaven and that the federal government will not have any power left? What will be the position of the federal government to reconcile provinces when difficulties or disagreements arise?

Mr. Clark: Mr. Speaker, I wonder whether the hon. member speaks on behalf of his party when he suggests that we cannot consider changing the administration of the home insulation program to help facilitate its implementation. The idea is to have the most efficient and effective program possible and we think that we could certainly be more efficient without this transfer being a loss of jurisdiction and power.
