SHUTDOWN OF BRITISH COLUMBIA SHAKE AND SHINGLE INDUSTRY

Mr. Gerry St. Germain (Mission-Port Moody): Mr. Speaker, a study just completed in the eastern half of my riding by the Dewdney-Alouette regional district has found that the unemployment rate there is 47 per cent, or nearly half the work force. This unemployment is largely due to the shutdown of the shake and shingle industry. In spite of millions of tax dollars having been paid to all levels of government by this industry, no assistance or incentives have been put forward for research and development, or market development. We now have a major export industry in trouble simply because no planning or forethought was undertaken. We need economic development and diversification in our local economy to address this crippling unemployment problem. With almost half the work force unemployed, no retail operation, business, or family remains unaffected.

I am not looking to blame anyone; I am looking for solutions and immediate action. Partisan politics must be shoved aside. I call upon the Government to sit down with the Dewdney-Alouette regional district representatives when they visit Ottawa next month, along with myself, to discuss this problem. I suggest, Mr. Speaker, and I believe, we must take this opportunity to initiate a major reforestation and R and D effort to preserve this area's largest industry. Haggling between the provincial and federal Governments over reforestation is hurting our entire country, not to mention the citizens of my riding.

REQUEST FOR FEDERAL GOVERNMENT CO-OPERATION

Mr. Gaston Gourde (Parliamentary Secretary to Solicitor General of Canada): Mr. Speaker, last week, the plan to modernize Davie Shipbuilding Limited entered a new phase

when the Government of Quebec decided to provide a grant of \$4.95 million. Although some time ago, the Quebec government decided to put everything on hold because of the possibility that Davie Shipbuilding might be sold, for some reason it has now changed its position. However, its initial refusal has set back a study of the plan by several weeks. In any case, it seems that federal officials have been informed they can proceed with consideration of the application for a grant from the federal Government.

I therefore urge the federal authorities to act as soon as possible, bearing in mind the importance of Davie Shipbuilding for the Quebec City region. I would ask all intervenors to give this matter the attention it deserves. The situation at Davie Shipbuilding is not very encouraging, but if this plan were to become a matter of co-operation instead of confrontation, both the company, its employees and the region would benefit.
