Supply

I believe that there is a change of attitude reflected in what was said this morning by the Hon. Minister for International Trade (Mr. Kelleher), who announced that he would meet Friday with the main parties involved, namely the industry and the provincial Government, to try to identify the best alternatives. This Government has no intention of imposing its own views on anyone. There are industries and provincial Governments involved. We have to examine the best solutions to this problem. Naturally, we have had to make some changes.

If we look at the various issues which have been the subject of sporadic controversy, it becomes obvious that it was more than time for the Canadian Government to take a comprehensive look at the framework of our trade negotiations in recent years. Our current problems have existed for a long time. Canadians are now very much sensitized to the problems associated with our trade relations with the United States. They want to hear about them. This is part of what the Government can do to help them.

Since last year, there have been some changes within the Canadian Government. I have heard people speak about the foreign investment act, the National Energy Program and all the programs implemented by the former Government which exacerbated the problem. We all know, Mr. Speaker, that we have known difficult times. We are now coming out of them. However, when, during a difficult period for trade, we add to the problem with legislation which unilaterally makes Canada hostile to trade, we find ourselves with problems such as the one we are now having.

We have a second problem which will have to be resolved by the International Trade Commission: Afterwards, we shall be able to decide what action to take to help the industry. In this specific case, it is important for the Canadian Government to provide immediately some practical assistance to the industry and the province most affected to guarantee their defence before the International Trade Commission.

making the Canadian case before the United States International Trade Commission; (3) to ensure that proper time is given to make this case by, if necessary, obtaining extensions to the hearing time; (4) and by initiating proper and effective action under the rules of GATT to ensure that this matter is satisfactorily considered by the international trading system.
