ada has not received annual payments from fishermen in the Scotia-Fundy region. There are therefore no outstanding payments for Scotia-Fundy fishermen for 1991.

In the fall of 1991, the Minister of Fisheries and Oceans announced the formation of a Task Force on Dockside Monitoring. Over the past months, the task force has been studying how the program can be designed to apply on a consistent basis in eastern Canada and how it should be financed. The task force should forward its recommendations for ministerial consideration in the upcoming months.

## CANADIAN ENVIRONMENTAL ASSESSMENT ACT

#### MEASURE TO ENACT

The House resumed consideration of Bill C-13, an act to establish a federal environmental assessment process, as reported (with amendments) from Legislative Committee C; and Motions Nos. 11 and 18 of Mr. Caccia (p. 8263).

Madam Deputy Speaker: I see the hon. member for Skeena seeking the floor. He has spoken.

Mr. Fulton: Madam Speaker, I was just checking to to make sure that I had a chance to speak.

Madam Deputy Speaker: The hon, member has spoken on this motion.

Mr. Taylor: Madam Speaker, I rise on a point of order. The member for Port Moody—Coquitlam was on his feet when we adjourned for Question Period. I believe that he is just coming into the Chamber right now, and I am wondering if the Chair could recognize him to complete his remarks.

Madam Deputy Speaker: The hon. member for Port Moody—Coquitlam, welcome back.
