Read second time and referred to Committee on Railways, etc., 263. Reported amended, 499. Bill referred back to Committee on Railways for further consideration, 528. Reported amended, 551. Considered in Committee of the Whole; progress reported, 560. Again considered; reported amended; considered as amended; read third time (Title changed to "Montreal Terminal Railway Company") and passed, 588. Passed by Senate with an amendment, 652. Agreed to, 665. Royal Assent, 846.—62-63 Victoria, Chapter 76.
