That Whereas this House, during the first Session of the present Parliament, in order to economize its expenditure, reduced the Salaries of certain of its Officers and Clerks on the Staff of the Department, and no increase has since been made to the said salaries or emoluments.

*Resolved*, That in the opinion of this House, such of the Officers and Servants of this House as His Honor, the Speaker, the Honorable the Postmaster General and the Honorable the Receiver General may consider entitled from length of service or capacity should have such reasonable addition to their Salaries as will compensate them fairly for their work, for the current year and until their cases may be considered by this House.

The question of concurrence being put thereon, the same was unanimously resolved in the affirmative.
