HEAVY FEES FROM ROYALTY.

Max O'Rell's Interesting Gossip About English Characters of Note.

New York, Aug. 24.—Under a Paris date Max O'Rell sends the following interesting gossip: It is a good thing to be a physician, to be called to the bedside of a royal patient. For his four weeks' attendance at Sandringham prior to the recovery of the King from typhoid fever, in 1871, Sir William Gill received \$50,000.
