REPORT OF MEMORIAL COMMITTEE.

Your Committee, having considered the communications referred to them, beg to present the following report :—

1. On the memorial from the Chatham District, *re* the registration of Indian marriages on Walpole Island, your Committee would suggest that the Chairman of the Chatham District be requested to inquire into the matter, and, if provision has not been made, to call the attention of the Indian Department to the necessity for such provision.

2. Respecting the matter of Louisville Circuit, seeking a refund of moneys said to have been paid toward the erection of the late C. M. and M. E. parsonages in Thamesville, your Committee would recommend that the Chairman of the Chatham and the Chairman of the Ridgetown Districts be directed to appoint an arbitrator each, these to select a third, in order to effect a settlement in the case.

REPORT OF THE CHURCH PROPERTY COMMITTEE.

Your Committee beg leave to report the following recommendations concerning church property referred to it by the Conference :—

1. That permission be granted the trustees of the Queen's Park Church, London City, to sell the property and apply proceeds to the erection of a new church for the use of the united congregation of Queen's Park and Elizabeth Street.

2. That the request of the trustees of Elizabeth Street Church, London City, to sell the old property and proceeds be applied according to discipline, be granted.

3. That the request of the trustees of the Bethel Church, Grand Bend Circuit, to sell the property, and proceeds be applied to the parsonage debt of said Circuit, be granted.

4. That permission be granted to the trustees of the parsonage property, Malahide Circuit, to exchange a portion of land on the south side of the parsonage lot for an equal portion on the west side.

5. That the memorial from the Louisville Circuit be referred to the Memorial Committee.

6. That the request of the trustees of the Bethel Church, Comber Circuit, to sell the church and apply proceeds on the Tilbury Centre Church, be granted.

7. That permission be granted the trustees of parsonage, Woodslee Circuit, to sell the parsonage property, and apply proceeds on the new parsonage.

8. Concerning the Northwood Church, Harwich Circuit, the following resolution we passed unanimously :—That having considered the case of Northwood Church, Harwich Circuit, Ridgetown District, your Committee recommend, that because of the difficulties involved in the case, they refer the question back to the Conference for any action deemed wise.

9. That the request of the trustees of the Methodist Church, McKay's Corners, Harwich Circuit, to sell the church property, proceeds to be
