TAKE NOTICE that The Dufferin-Peel County Roman Catholic Separate School Board on the 21 day of July, 1970 passed By-Law Number 11 to authorize the borrowing of money by the issue and sale of a Debenture of the said Board in the principal amount of \$313,000.00.

1. The Purpose for which the money is to be borrowed is the construction of separate school accommodation and the supply of equipment.

Effect of the By-law

By-law No. 8409, approved by the Board on the 1st day of May, 1970, incorporated the provisions of and the lands regulated by By-law No. 2273 into By-law No. 5500, and By-law No. 5500 so extended has complete effect throughout the whole of the Town of Mississauga planning area.

To conclude this matter, it is necessary to repeal By-law No. 2273 because at the present time lands in the former Malton planning area are regulated by both By-law No. 2273 and By-law No. 5500. Therefore, the effect of the repeal of By-law No. 2273 is that the lands in the Malton area will be regulated only by By-law No. 5500, as so extended, as are all other lands within the Town of Mississauga.

Location of lands affected

All lands in the Town of Mississauga located north of Base Line Road and east of a line between the east and west half of Concession Three (3), East of Hurontario Street, with the exception of all of Lot One (1) in the Fourth Concession, East of Hurontario Street. 1971 to 1990, as follows:
