An early morning blaze, originating in the plant of the Campbell Hosiery Company, 19 King street, caused between \$20,000 and \$23,000 damage to that establishment and to Charles R. Will & Co, manufacturing pharmacists, on the second floor of the same building, before it could be checked by firemen. Chief Aitken attributed the cause

of the fire to an electric stove in the Campbell factory.

The building in which the two firms

are located is situated behind Wil-liam Ward & Sons' cigar factory, and is owned by that company. The build-ing itself is not damaged to any great extent. floor and dense black smoke was issuing from the second-story windows. It was only after a strenuous fight that the blaze was checked.

The Will Company had accumulated a large stock, and the major portion of it was totally destroyed by smoke and water. The blaze was checked before it could make much headway upstairs, but Charles R. Will told The Advertiser today that his stock had been damaged as much as if the fire had gutted their quarters.

The company officials have not completed a survey of the stock destroyed, but Mr. Will places the loss at between \$7,000 and \$8,000.

Impulsive Action. "The crime alleged to have been connection with Greek policies and aspirations, and I know either country would jump at the chance of embarrassing the Greek government and

precipitating war.

"Conditions in Naples, Genoa and other Italian cities are worse than they are in any other part of the world. When I was there nine weeks ago thousands of women and children were begging alms on the streets. Italy is in as unfavorable position as Greece, so far as military aggression is concerned. Neither country could stand a protracted war. They are on the verge of social and

industrial exhaustion "It is grossly unfair of Italy to take advantage of a defenseless country, and it is unfair for Mussolini to eopardize the lives of his own peo ple. Of course the Italian premier is strongly entrenched in the hearts of the people. He is a national hero and his affiliation with the Fascisti, a patriotic body of loyalists, insures his almost universal support.
