Tariffs on fruit and vegatable juices ranged from 0.3 cents/litre to 9.25 cents/litre. Apple juice is duty free. Under the Free Trade Agreement, all tariffs on juices will be removed by January 1, 1998, with duties reduced in ten equal stages.
