THIRD (SPECIAL) SESSION—TWENTY-FIRST PARLIAMENT—OPENING

The parliament which had been prorogued on the thirtieth day of June, 1950, met this day at Ottawa for the dispatch of business.

The house met at three o'clock, the Speaker in the chair.

Mr. Speaker read a communication from the Governor General's Secretary, announcing that His Excellency the Governor General would proceed to the Senate chamber at three o'clock p.m. on this day, for the purpose of formally opening the special session of the dominion parliament.

A message was delivered by Major C. R. Lamoureux, Gentleman Usher of the Black Rod, as follows:

Mr. Speaker, His Excellency the Governor General desires the immediate attendance of this honourable house in the chamber of the honourable the Senate.

MAINTENANCE OF RAILWAY OPERATION ACT

PROVISION FOR RESUMPTION OF RAILWAY OPERATIONS AND SETTLEMENT OF LABOUR DISPUTE

Right Hon. L. S. St. Laurent (Prime Minister): Mr. Speaker, I move, seconded by the Minister of Trade and Commerce (Mr. Howe), for leave to introduce Bill No. 1, to provide for the resumption of operations of railways and for the settlement of the existing dispute with respect to terms and conditions of employment between railway companies and their employees.

I am not this afternoon presenting the usual pro forma bill, an act respecting oaths of office. I am proposing rather to introduce a bill respecting the disruption of the railway
