NORTH PACIFIC COMMISSION-EXTENSION OF JAPANESE FISHING RIGHTS

On the orders of the day:

Would the minister care to indicate to the house by what means the government intends to implement this decision?

Hon. H. J. Robichaud (Minister of Fisheries): In reply to the hon, gentleman I would advise him, and advise the house, that the matter comes under the jurisdiction of the Secretary of State for External Affairs. [Later:]

Mr. Douglas: I should like to direct a question to the Secretary of State for External Affairs. In view of the fact that the Minister of Fisheries has indicated that the government has decided to accede to the recommendations of the international north Pacific fisheries commission, what means does the government propose to take to implement that decision? Will the government bring down legislation to amend the treaty, or does it intend to deal with the matter by executive order?

Hon. Paul Martin (Secretary of State for External Affairs): As my hon. friend knows, following the announcement which was made last week this matter of renewal of the treaty is now under negotiation outside of this country with regard to the consideration of the abstention principle so far as Japan is concerned. With regard to the question my hon, friend asked, I may say that after we have had an opportunity of ascertaining the results of these negotiations we will be in a position to announce in this house the course that we believe should be taken.
