PROPOSED INTERNATIONAL PROTOCOL—EFFECT OF CANADIAN COMMITMENTS ON LE DAIN COMMISSION REPORT

Mr. P. B. Rynard (Simcoe North): My question is addressed to the Minister of National Health and Welfare. Now that the minister is back in the House after meeting his provincial colleagues, does he intend to make a statement concerning the commitments the government could enter into in regard to the Geneva protocol on psychotropic drugs and the effect of these commitments on the recommendations of the Le Dain Commission?

Hon. John C. Munro (Minister of National Health and Welfare): Mr. Speaker, I do not think a long statement is necessary. I can assure the hon. member that I do not believe it is the intention of the government to make any commitments of a binding nature until it receives the final report of the Le Dain Commission.

Mr. Don Mazankowski (Vegreville): Is the minister now in a position to advise the House on the nature of the answer relayed to the directors of the provincial antiaddiction programs who have urged the government not to proceed to enter into any international drug agreement prior to the completion of the Le Dain report.

Mr. Munro: Mr. Speaker, I would hope my previous answer would answer the hon. member also.

Mr. Rynard: Mr. Speaker, I should like to ask the minister whether he can assure the House that no commitments will be made at Geneva until he comes back to the House and such agreements are fully ratified by Parliament?

Mr. Munro: Mr. Speaker, I would hope that my previous answer would give the House and the hon. member that assurance.
