### FINANCIAL ADMINISTRATION—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

It has to do with maladministration of the National Museums of Canada as evidenced by the prolonged absence of highly paid museums' officials from their offices while touring foreign countries at considerable public expense. There is also the matter of contracts let by the museums branch for publications as far back as 1967 which to my knowledge have not yet been delivered.
