Hon. Allan J. MacEachen (Acting Prime Minister): Yes, Mr. Speaker. The government of Canada does support the call of the Anglican Primate for an independent inquiry into these tragic deaths. The government of Canada has already made known to the representative of Uganda in Canada that in our view, an independent inquiry is justified in the present circumstances. Therefore, we have no hesitation in supporting strongly and sincerely this particular request.

CANADIAN EFFORTS AT UNITED NATIONS TO PROTECT HUMAN RIGHTS

Mr. Douglas Roche (Edmonton-Strathcona): Expressing the dismay of members on this side that the motion of the hon. member for St. John's East on this particular point yesterday was denied, may I ask the Acting Prime Minister a supplementary question? In view of the escalating violations of human rights in many parts of the world—Russia, Czechoslovakia, Chile, Indonesia, to name just a few countries as well as Uganda—can the Acting Prime Minister tell the House what instructions have been given the Canadian representative to the United Nations Human Rights Commission to help the United Nations increase its worldwide efforts to protect human rights?

Hon. Allan J. MacEachen (Acting Prime Minister): Mr. Speaker, so that there will be no misunderstanding on this point, I should refer to the incident which occurred yesterday. We did not refuse to accept the hon. member's motion on substantive grounds but on procedural grounds—

Some hon. Members: Oh, oh!

Mr. MacEachen: —because the action called for in the motion had already been taken by the government of Canada. Therefore, there would be no reason to oppose it on substantive grounds. With regard to the United Nations Commission on Human Rights, I am pleased to advise the hon. member that the government has already acted. Prior to his question, we instructed our representative to the United Nations Commission on Human Rights, Mr. Beaulne, to take an active hand in bringing this particular incident in Uganda to the attention of the United Nations.

Mr. James A. McGrath (St. John's East): Mr. Speaker, I thank the minister for that explanation of the unusual action in the House yesterday.
