M. Pitfield to Mr. J. Clark, dated June 1, 1979, and a copy of any Order-in-Council of the outgoing administration relating to the Convention or the said letter (f) the outgoing Clark administration and the incoming Trudeau administration in 1980, including a copy of the letter relating to this subject directed to Mr. P. E. Trudeau, dated February 29, 1980.
