CONSUMER AFFAIRS

DRUG PRICE INCREASES

Ms. Margaret Mitchell (Vancouver East): My question is for the Minister of Consumer and Corporate Affairs who is also responsible, supposedly, for consumers.

We have learned that the price of generic labelled drugs has dropped about 1 per cent in Manitoba while prices of many brand name drugs have increased over 100 per cent in some cases.

Oral Questions

Will the Minister explain, especially to four million Canadians who have no drug plan at all, why his friends, the multinational corporations, are being so greedy? Will he also explain to consumers why he is doing nothing as Minister for Consumer Affairs to stop this price rip-off?

Hon. Harvie Andre (Minister of Consumer and Corporate Affairs): Mr. Speaker, as the Hon. Member will know or should know, if she were following the debate on Bill C-22, there was nothing in Bill C-22 which could in any way shape or form contribute to an increase in the price of existing drugs. Even the most severest critics of Bill C-22 acknowledge that fact.

She may also be aware that, for example, in 1983 the CPI went up 5.8 per cent while the price of drugs went up 12.8 per cent. In 1987 the price of drugs went up 8.9 per cent while the CPI went up only 4.4 per cent.

The Member will also be aware that Bill C-22 provided for the creation of a Patent Medicine Price Review Board which has the power to keep the price increases of drugs below the cost of living unless there is justification not to. In other words, it will exercise a downward pressure on prices. The reason the Board is not in place and working now is because of the delaying tactics of her colleagues and friends in the Liberal Party. If she wants to blame someone for current price increases, she should blame her colleagues sitting around her.

REQUEST FOR REVIEW OF DRUG PRICES
