Mr. Turner (Ottawa-Carleton), seconded by Mr. Drury, by leave of the House, introduced Bill C-26, An Act to amend the Civil Service Insurance Act, which was read the first time and ordered to be printed and ordered for a second reading at the next sitting of the House.

The text of the Message and Recommendation of the Administrator pursuant to Standing Order 62(2) in relation to the foregoing Bill is as follows:

His Excellency the Administrator recommends to the House of Commons a measure to amend the Civil Service Insurance Act; to extend the meaning of children to include adopted children; and to extend the application of the Act to provide where the insured may be a married or unmarried woman and, to provide for the unmarried woman's future husband and children.
