Cairo. Nov, 16 .-- Suleiman Daud was examined before the Prosecuting committee to-day. He admitted that he gave the order to fire Alexandria, but lleged that he received peremptory orders to do so from Arabi, who, when a general conflagration was not at first ap-parent, sent Mahmound Sami several times with instructions to Suleiman to fire more prints at a time. Suleiman further alleged that when Ramish Palace was surrounded by troops, on July 12, Arabi ordered him to murder the Khed Arabi ordered him to murder the Khed-ive.
