The plan was to remove Shippy for the benefit of the community, and Avrahim, who professes to be a "pimp" for the anarchists, is reported to have made his way to the Chicago police station on Friday, and that he was willing to talk of those seeking to prevent the spread of anarchistic doctrines.

MORAL REFORM CONVENTION.

Opens in Calgary—Dr. Shearer Ad-

Calgary, March 4.—The second annual convention of the Alberta Temperance and Moral Reform League met in general session at the Hotel Macdonald, Calgary, today. Dr. J. D. Blayney, occupied the chair, and there were about one hundred delegates present. This afternoon the executive committee met and prepared a programme. At the evening session various committees were elected and Dr. J. G. Shearer, Toronto, delivered an address on the subject, "The Objects of the Temperance and Moral Reform League in the Dominion." One object was the preserving of the Lord's Day as an inheritance for all citizens of the country, and the second object was temperance reform. He said economic considerations were for the first time to a large extent coming to the aid of an appeal for temperance through religious and moral principles.

TAX DOMINION OFFICIALS.

B.C. Government Will Insist Upon
Payment of Poll and Income
Taxes.

Vancouver, B.C., March 1.—The provincial tax collector has notified every Dominion government employee in British Columbia that they will have to pay poll and income tax following the recent decision of the New Brunswick case by the Privy Council. The decision reported in the Vancouver registry office last month was the largest in the city's history. The customs also show a great increase. The Blue Funnel freight liners, which run between Pacific coast points and England, are arranging to soon make regular calls at Prince Rupert. When railway construction commences it is expected that the freight charges will be reduced.

AMENDMENTS TO ELECTION ACT

Campaign Funds Must Be Made
Public. Heavy Penalties
For Bribery.

Ottawa, March 4.—Hon. A. B. Aylesworth has given notice of a bill to amend the Dominion Election Act. This measure, besides making a number of amendments to the present act, along technical lines, with a view to making clear the real interest of law, provides for the payment of a number of judges and the prohibition of officers in respect to the publicity of contributions to campaign funds, the manipulation of ballots, etc. It is provided that contributions to candidates campaign funds must be made direct to his legal agent and must be published by him. No election contributions can be made by any incorporated company under penalty of a fine of \$1,000 on each director or imprisonment for two years. A heavy penalty is provided for the bribing of voters to take electors to the polls, and the man who pays for the conveyance, as well as the ivoryman, is made liable to the penalty.
