UNEMPLOYMENT INSURANCE ACT-EMPLOYEES

Mr. DIEFENBAKER:

How many appointments have been made to date in connection with the Unemployment Insurance Act, and what number of employees is it anticipated will be required in order to administer said act?

Mr. McLARTY:

Appointments: Permanent, 2 commissioners, 1 chief commissioner, later deceased, whose place has been taken by an acting chief commissioner, 8 officials; temporary, 11 clerks and stenographers; on loan from other branches of government service, 7 clerks and stenographers; total, 29.

The unemployment insurance commission reports that its procedures and plans have not as yet been developed to the point where an accurate estimate of the number of employees which will ultimately be required to administer the act may be made. During the hearings before the special committee appointed by the House of Commons to consider the unemployment insurance bill in July, 1940, an approximation was stated to be in the neighbourhood of 3,000 employees.

CANADIAN ARMY-PROVISION FOR DEPENDENTS

Order in council P.C. 1971 of the 21st May, 1940, provides that the provisions of section 11 (2) of the Pension Act shall apply in respect of disability or death incurred by members of the naval, military or air forces of Canada while serving in Canada after that date. Under that section of the Pension Act, pension may be awarded the dependents of a deceased member of the forces when the injury or disease or the aggravation thereof resulting in death arose out of and was directly connected with such military services.

2. The same provisions apply to members

of the reserve army while on duty.
