PRIVILEGE

REFERENCE TO PRESS REPORT AS TO BUDGET FIGURES ON FOREIGN EXCHANGE POSITION

Hon. DOUGLAS ABBOTT (Minister of Finance): Mr. Speaker, I think I should rise to a question of privilege to correct a press report of the figures which I gave in my budget speech last night with respect to our foreign exchange position. In the Canadian Press report which appears in this morning's newspapers it is stated:

The country's present foreign exchange reserves are \$668,000,000 after drawings of \$130,000,000 on the Export-Import bank loan from the United States

The actual drawings on the And so on. Export-Import bank loan are only \$80 million and not \$130 million, and the net position is therefore \$588 million. I do not blame the reporter. It is no doubt due to the way in which my budget speech was phrased. I gave the figures to the end of March as \$607 million, of which \$50 million represented drawings upon the Export-Import loan. figures at the end of April were \$668 million, taking account of \$30 million drawn in April, or \$80 million in all.

R.C.A.F. BENEVOLENT FUND

Mr. McKAY:

1. What was the amount of the Royal Canadian Air Force benevolent fund on (1) September 30, 1945; (2) March 31, 1948?

2. What are the yearly charges for the administration of this fund?

3. What have been the disbursements and receipts with regard to the benevolent fund for each year since its inception?

Mr. LAPOINTE: The Royal Canadian Air Force benevolent fund was incorporated on the 1st April, 1944, under part II of the Dominion Companies Act. It is supported by contributions from service personnel and others interested, and is not administered by the Department of National Defence. However, the following information has been obtained from the corporation's annual reports:

- 1. 31st December, 1945, \$1,875,565.31; 31st December, 1947, \$3,194,368.03.
- 2. 1944, nil; 1945, \$1,583.54; 1946, \$18,252.68; 1947, \$39,657.38.
- 3. Disbursements: 1944, nil; 1945, \$33,319.50; 1946, \$112,076.53; 1947, \$195,299.73.
