COPYRIGHTS

REPEAL AND REPLACEMENT OF EXISTING LEGISLATION

Miss Judy V. LaMarsh (Niagara Falls) moved for leave to introduce Bill No. C-70, to provide for copyright in Canada and to implement the universal copyright convention.

Mr. Pickersgill: Explain.

Miss LaMarsh: This is the reintroduction of a bill which is simply intended to modernize legislation which has not been modernized since 1921.

Hon. E. D. Fulton (Minister of Justice): On a point of order, Mr. Speaker; I have no firm views on the matter, but I thought I should bring this to your attention and to the attention of the house. It is my recollection that there is already on the order paper government order No. 6, a resolution that it is expedient that the houses of parliament approve the universal copyright convention signed by Canada at Geneva in 1952, etc.

I confess I have not given attention to the details of the question, but it did occur to me that it might be appropriate to bring the matter to Your Honour's attention, perhaps for consideration later, as to whether it is proper that the hon. lady should be given leave to introduce her bill at the present time.

Hon. J. W. Pickersgill (Bonavista-Twillingate): Perhaps I may be allowed to say a word on the point which has been raised. It would appear to me that a resolution of the house would have no legislative effect. What the hon. lady is seeking to do is legislate to change the laws of Canada. There does not seem to houses of parliament approving a convention it is far too long for oral question and answer. which has been entered into and subsequent legislation to implement that convention.

Mr. Speaker: I thank the Minister of Justice for drawing attention to the possible point of order. I think no conflict arises at this stage, though it might as the bills progress if they turn out to be identical or very similar; because the house cannot, of course, carry on the same debate under two headings. But at this stage I think there is no obstacle to the hon. lady proceeding with her bill.
