ADMINISTRATION OF JUSTICE

AID TO VICTIMS OF CRIME

Hon. Marcel Lambert (Edmonton West): My question is directed to the Minister of Justice, Mr. Speaker. Can the minister advise whether his departmental officials have been conducting discussions with their opposite numbers at the provincial level with regard to the provision of a uniform system of aid to victims of crime, as well as to those who are called upon to aid police power and who are injured as a result of their actions in response to such calls?

Hon. John N. Turner (Minister of Justice): We have not been in active discussion with the provinces on this subject, but in the light of the hon. member's question I think it would be useful if at the next meeting of the uniformity commissioners we were to take this up with the provincial attorneys general.

HOCKEY—ACTION TO ABOLISH RESERVE CLAUSE

Right Hon. J. G. Diefenbaker (Prince Albert): May I direct a question to the minister of health, Mr. Speaker? It has to do with the recommendation of the commission on sports to the effect that reserve terms in National Hockey League professional agreements should be outlawed, and the hon. gentleman's statement that he was considering bringing in legislation to this effect. Would the minister say, having regard to the statement by the president of the National Hockey League that parliament has no jurisdiction to do this, whether any opinion has been secured from the law officers of the Crown and, if so, what is the nature and the purport of the advice he has received?

Hon. John C. Munro (Minister of National Health and Welfare): I would answer the right hon. gentleman by referring him to the reply my colleague the minister of Consumer and Corporate Affairs gave in the house yesterday to the effect that, despite Mr. Campbell's opinion, my colleague is looking into this matter.

Mr. Diefenbaker: I was not here yesterday, but I saw that answer. My question is: Has the matter been submitted to the law officers of the Crown?
