Mr. Gérard Laprise (Abitibi): Mr. Speaker, I wish to direct a question to the Minister of Transport.

Can the minister advise the House whether he has received a letter signed by a number of residents from Fort George, Quebec, to the effect that Nordair Airlines have decided to discontinue their services to Fort George? Can the minister also advise the House whether he has contacted Nordair Airlines, and whether he can assure Fort George residents that general services, including the delivery of mail, as well as medical, and fresh food supply, will not be cancelled to this northern community?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, I will verify whether I have received this letter, for I do not remember receiving it. However, I suggest that such an application for cancellation of service would not have been sent to the Minister of Transport, but to the Canadian Transport Commission, of which Mr. Benson is the president.

This is the body which is responsible for this decision. It is the CTC which decides whether to maintain the service or not. However, I am going to find out whether I have received the letter referred to by the hon. member.
