

ASPHALT PLANT EMISSIONS

Question No. 2,537—**Mr. Marshall:**

1. Under a news release outlining guidelines limiting the emission of particular matter into the air from asphalt plants, what action has been taken by the Department of the Environment (a) to demand that the 350 asphalt plants in Canada provide equipment to control emissions of particular matter (b) to have the asphalt plants make an effort to provide such equipment?

2. Have any of the asphalt plants applied under the accelerated capital cost allowance programme to provide such equipment and, if so, what are the names of such plants?

Mr. Len Marchand (Parliamentary Secretary to Minister of the Environment): 1. (a) Although national emission guidelines are not federally enforceable, the provincial agencies are encouraged to adopt these in order to promote a uniform nationwide approach to air pollution control. Several provinces have already indicated that their regulations would be based on the federal guidelines. The federal government does not have the authority to make any demands directly on the asphalt plants in Canada at the present time. (b) During the process of guideline development, consultation with the industries took place to ensure that a concerted effort would take place to obtain the necessary control equipment in asphalt plants in Canada.
