PUBLIC SERVICE EMPLOYMENT ACT

AMENDMENT RESPECTING STAFF OF MEMBERS OF THE HOUSE OF COMMONS

Mr. Paul E. McRae (Thunder Bay-Atikokan) moved for leave to introduce Bill C-215, An Act to amend the Public Service Employment Act (Staff of Members of the House of Commons).

Some Hon. Members: Explain.

Mr. McRae: Mr. Speaker, the purpose of this Bill is to provide reasonable security to staff of all Members of Parliament. Members will know that particularly at election time approximately one-third of the Members cease to be Members. As a result, something in the order of 300 staff members are without employment after years of faithful service.

The Bill would place the staff of all Hon. Members in the same situation as those in the Prime Minister's Office, the offices of the Leader of the Opposition and Cabinet Ministers. Where a staff member has three years of service, such staff member would have a priority right of access to the Public Service

The Bill is seconded by the Hon. Member for Lachine (Mr. Blaker), the Parliamentary Secretary to the Minister of International Trade. I can assure you that every effort will be made to secure the consent of all three Parties for what is a worthy attempt to achieve speedy passage of the Bill.

Motion agreed to, Bill read the first time and ordered to be printed.
