BUSINESS OF SUPPLY

ALLOTTED DAY, S.O. 62-PROTECTION OF THE ENVIRONMENT

The House resumed consideration of the motion of Mr. Caccia:

That, in the opinion of this House, the Government has displayed negligence with regard to the protection, maintenance and improvement of the environment as manifested in its ill-advised reduction in services, its complacent attitude toward controlling potential harsards and its complete abdication of any leadership in the protection of the environmental health and safety of Canadians.

Mr. Bill Blaikie (Winnipeg-Birds Hill): Mr. Speaker, just before the House rose for the luncheon adjournment I had been referring to the fact that the reaction of the Government to the PCB spill between Kenora and Ignace, and for all we know at many other points along the Trans-Canada Highway, points to the fact that there is a gap between the moral outrage felt by Canadians and the offence taken by Governments. I am not referring to any particular Government but to Governments in general. Often these kinds of incidents arise out of the negligence of either the private sector or respective Government Departments which are responsible for ensuring safe transportation of dangerous substances such as, in this case, PCBs.

One of the oddities of our society and our civilization is that we rightly get ourselves worked up about criminal acts, whether it be murder, theft, or whatever, acts which come under the traditional notion of what it means to act like a criminal. We have not reached the point—and I think we need to reach it very quickly—where we take moral offence at actions by Governments, the private sector or anyone responsible for introducing poisons into the environment with which human and non-human creatures have to live either in the short run or
