credit legislation and by changing the limited partnership legislation. A number of things have been done, but as I have indicated before, further work has to be done. I have never denied that. Further work must be done, but we are getting on with that and the Hon. Member will be hearing from me shortly on it.

# SAFETY OF GREAT LAKES DRINKING WATER

**Mr. Joe Reid (St. Catharines):** Mr. Speaker, my question is directed to the Minister of National Health and Welfare who probably read the same articles I read yesterday indicating that the water of the Great Lakes is polluted by some 800 chemicals, only 50 of which are subject to safety guidelines. What further research does the Minister propose to undertake on this source of drinking water for millions of people on both sides of the border so as to improve upon the classification, which is now simply stated as being generally safe?

Hon. Jake Epp (Minister of National Health and Welfare): Mr. Speaker, the Hon. Member made reference to a study which was funded by the Ontario Environmental Ministry and the Department of National Health and Welfare. He has analysed it correctly in that drinking water is generally safe. It is true as well that with the present research and the ability to trace various toxic chemicals, a number of—

#### ELDORADO NUCLEAR—LOCATION OF WASTE DISPOSAL SITE

Mr. Bill Blaikie (Winnipeg—Birds Hill): Mr. Speaker, my question is for the Minister responsible for Eldorado Nuclear. The Minister will be aware of the concern about Eldorado's intention to locate a nuclear waste disposal site at one of two locations, either Wesleyville or Tyrone. Does the Minister intend to instruct Eldorado to shelve its proposals and go back to the drawing board, in keeping with the Prime Minister's campaign pledge that a dump site would not be located in these areas?

Hon. Gerald S. Merrithew (Minister of State (Forestry and Mines)): Mr. Speaker, naturally that particular issue has been a matter of some concern to me. I have been reviewing that dossier since my appointment and since I have had responsibility for that particular issue.

I can tell the Hon. Member that I have had a great many discussions on the issue with many people, and particularly with the Hon. Member for Durham—Northumberland who has given me a number of suggestions. In that regard I might mention that I will be visiting that particular area tomorrow and we will wait to see what happens at that time.
