## **EXPO 92**

Mr. Nelson A. Riis (Kamloops): Mr. Speaker, I rise again today to ask the Secretary of State for External Affairs to tell Canadians the truth about the boondoggle known as the Canadian pavilion at the World Exposition in Seville, Spain.

Yesterday I referred to a departmental document that said that the budget would rise by \$10 million. Now it appears that the actual rise is even higher, from \$33 million to at least \$46.7 million, a \$13.7 million overrun so far.

I have another document in my possession, also from external affairs, dated October 6, 1989, which shows that the minister's officials knew the construction budget for the pavilion had been underestimated by 50 per cent. This clearly shows that the massive cost overruns plaguing this project are not just the result of unforeseen disasters in the past six months. It has been going on for a year and a half.

Yet at the same time that the government is spending more and more money on a pavilion in Spain which will be demolished at the end of the fair, the external affairs department has said that 306 positions will be cut in the next six months as a result of the federal budget.

I ask the minister responsible to confirm just how much the disposable pavilion will cost and how many jobs in external affairs will have been sacrificed to finance this apparently bottomless pit.
