This is a government that took office in 1984, talked about tax reform and then proceeded to install 32 tax increases, including this poorly designed GST, at the worst time in our economic history in terms of a downturn. I do not believe for a minute that Canadians are going to stand by and just say that they want another four years of Conservative rule and that they want another four years in which, according to the latest numbers from Statistics Canada, there are 2.2 million people receiving welfare and 1.5 million people on unemployment insurance. Last year we spent close to \$35 billion on welfare and unemployment insurance and the interest on those costs.

Speaking constructively about an idea that the government came up with just before Christmas, the Small Businesses Loans Act, we all know the greatest hope for new job creation lies with small business. The Small Businesses Loans Act was a good idea that the government had, but once again it has managed to screw even that up. It is unbelievable what it can do to a good idea. It thinks that Canadians are stupid. It was an idea that was announced in December to put some cash, some capital back into the hands of small business because that is where the job creation potential is and that is where our greatest hope is.

It has no sense of urgency. It does not realize that the bank manager will come knocking on the door saying: "Hey, your mortgage payments are behind" or "Mr. Small Businessman, your overdraft is unacceptable. We are not going to help you any more".

The government does not understand the sense of urgency. It does not understand when people are out of work or are about to lose their homes or their jobs or their businesses, the slap in terms of personal dignity that takes place. It seems to coast along takes its time. I believe Canadians during the next election are going to remember the deep pain the government has inflicted on them.

I am not suggesting for a second that any party, any person has the magic answer or has the magic wand to correct a global recession. That is not where I am coming from. I am coming from a point that when people are in deep pain and are looking to their leaders to give them some hope, this government sort of throws up an idea but then takes its time in implementing it.

I know of small businessmen dealing with this government who have been waiting in some cases for a year and a half, up to two years, to get action on files that they requested of this government. This lack of urgency, this seeming indifference to people when they are in deep pain, is going to be this government's legacy when we go to the people over the next few months.

As I said, I do not think for a minute we have a flash answer to correct all that ails us. Throughout history even with the flaws in the Liberal Party, and I know from time to time we have incurred larger deficits and therefore caused more debt in this country's Treasury, the Liberals, if one goes back 50 years, have the greatest record for putting people back to work.
