

FLEWELLING, GABRIEL HUDSON.

S. of the late Hon. W. P. Flewelling. B. at Clifton, N. B., 13 May, 1842. M., 16 Sept., 1863, at Long Reach, N. B., Miss Augusta Whelpley. Is a shipbuilder and merchant, a Captain in Reserve Militia, and Auditor for the Municipality of King's Co. An unsuccessful candidate for present seat in Leg. Assem. in N. B. at g.e. 1878. First returned to Ho. of Assem., 27 Sept., 1882, on death of the sitting mem., Hon. J. H. Crawford, and sat until apptd. to L.C., 26 March, 1886. A Liberal Conservative.—*Clifton, N.B.*

HANINGTON, *Lieut.-Col. Hon.* DANIEL, J.P.

S. of the late William Hanington, Esq., formerly of London, Eng., who settled in Shediac, N.B., 1770, by the dau. of a U.E. Loyalist. B. at Shediac in 1804. Ed. at the Sackville Grammar School. M., 1831, Margaret, dau. of William Peters, Esq., formerly mem. for Queen's in the N. B. Assem. Is a farmer and Lieut.-Col. Westmoreland Co. Militia. Was a mem. of Ex. Council from 1850 to 1851; and has been Speaker of the Houses of Parliament. Sat for Westmoreland in N. B. Assem. from 1833 until 1862. Apptd. to L.C., 1867. Was Speaker of the House from 22 Feb., 1882, until 1886. A Liberal.—*Shediac.*

HARRISON, *Hon.* ARCHIBALD.

Grandfather, James Harrison, was a U.E. Loyalist. S. of Hon. C. Harrison, late M.L.C. B., 27 May, 1834, at Cambridge, Queen's Co., N.B. M. 5 Nov., 1862, Amy, dau. of W. S. Barker, Esq., of Sheffield, N.B. Is a farmer. Has been Warden of the Co. of Sunbury, and was apptd. a mem. of the Senate of the Univ. of N. B., 1872. Unsuccessfully contested Sunbury in N. B. Assem. 1868. Sat for Sunbury in that House from g.e. 1870, until 8 April, 1874, when called to L.C. Apptd. a mem. of the Ex. Council 3 March, 1883. A Liberal.—*Maugerville, Sunbury Co., N.B.*

HILL, *Hon.* GEORGE FREDERICK.

S. of the late Hon. George S. Hill, barrister, who was for twenty-eight years a mem. of the Assem. and L.C. of N.B. B. at St. Stephen, Feb. 1832. Ed. there and in U.S. Admitted an Attorney in 1854. Went into mercantile
