The first part of this question, however, asks for correspondence between the two governments in this matter. Such correspondence, being diplomatic correspondence between two governments with a view to working out an international agreement, and in that sense working papers leadup to that agreement, is normally privileged and not made public. There would therefore be a very real difficulty in producing that correspondence, quite apart from the fact that the consent of the United States government would have to be obtained.

Mr. Diefenbaker: Would the minister allow a question? Would the United States government raise any objection to producing that correspondence?
