## AIR TRANSPORT

PUBLIC INQUIRY INTO CRASH OF T.C.A. PLANE

Hon. Guy Favreau (Minister of Justice): Mr. Speaker, I should like to advise the house that the Minister of Transport has decided that a public inquiry should be held into the tragic loss of the aircraft at Ste. Thérèse, Quebec, on November 29, 1963, and that I have ascertained that Associate Chief Justice Challies of the superior court of Montreal is willing to undertake this inquiry.

In view of the magnitude of the accident and the great loss of life, it was considered desirable by the government that the inquiry should be conducted by a judge of the superior court, and I am sure there will be general satisfaction that Mr. Justice Challies is willing to act. The board of inquiry will be formally established and its terms of reference announced next week.
