## INDUSTRY

EXCESS OF IMPORTS OVER EXPORTS UNDER AUTOMOBILE AGREEMENT

On the orders of the day:

Mr. A. D. Hales (Wellington South): Mr. Speaker, I direct my question to the Minister of Industry. In view of the fact that at the close of the first year of operation of the Canada-U.S. car treaty the imports of cars, trucks and parts into Canada from the United States had exceeded our exports by the alarming figure of \$726 million, will the minister advise the house what steps he proposes to take to stop this dangerous trend which is so adversely affecting our imbalance of trade?

Hon. C. M. Drury (Minister of Industry): Mr. Speaker, I did not catch the figure mentioned by the hon. gentleman, but I think perhaps he is referring to the excess of imports in the calendar year 1965, which was something in the order of \$770 million.

I have some figures here which indicate that in the first six or seven months of this year this imbalance was substantially reduced. Not only was the rate of imbalance reduced, but in the month of July the net import balance was only \$15 million. I do not suggest that we can anticipate a deficit of only \$90 million for the remainder of the year, but this does show a trend in the right direction which had particularly spectacular results in the month of July.

Mr. Hales: The minister said he did not hear the figure I mentioned. That figure was \$726 million.

Mr. G. W. Baldwin (Peace River): I have a supplementary question. Bearing in mind the circumstances, the dislocation of employment and the changes in the prices of automobiles, can the minister say whether the government is satisfied with the operation of this Canada-U.S. automotive treaty?

Mr. Speaker: Order, please. I suggest to the hon. member that his question is not in order.
