Mr. Gilles Grégoire (Lapointe): Mr. Speaker, a supplementary question. Can the Postmaster General tell us whether it is true that the French copy of the Montpetit report sells for \$2 while the English copy sells for \$1, and could the minister tell us why?

Mr. Speaker: I do not think that this question is in order.

Mr. Côté (Longueuil): I believe, Mr. Speaker, that it is necessary to point out that both editions, French and English, were selling for \$1 each and that the new issue, French or English, will sell for \$2 each.
